A Message from the Principal

To our Lincoln Heights Elementary School families:

This is the first School Progress Report for Lincoln Heights Elementary. We are sending this to you so that you may be fully informed about our students' academic progress, our staff and our school environment.

Our school has a long history of strong community support and involvement. Several generations of Lincoln Heights families have attended our school, and they clearly feel great pride in their association with us.

Lincoln Heights is a partial Learning Immersion and Talent Development magnet school. The Learning Immersion and Talent Development programs allow student learning to be accelerated through a rigorous curriculum focused on the strengths of each child. Both programs provide an enriching environment that fosters scholarly behaviors, critical thinking and problem-solving skills based on Howard Gardner's theory of multiple intelligences. Simply put, this is a theory that recognizes and encourages individual learning styles.

Our school serves a diverse population, and we have a number of programs for children with varying needs. Resources include an Exceptional Children Resource program, an autistic self-contained program, English as a Second Language program and a regular program for our neighborhood students.

A look at our academic proficiencies on standardized measures reveals areas of strength and areas needing improvement. On our state ABCs standard, we met Expected Growth for 2007-2008 and made a significant 15.7 percent growth on our fourth-grade writing test.

The state introduced a new reading test in 2007-2008. As a result of more rigorous expectations, reading scores declined across the state, including in CMS. Since the new test covers different material from that covered in the previous test, direct year-over-year comparisons are not necessarily accurate.

CMS Accountability Measures

In this section, we are highlighting several key performance indicators for our school and its students.

► Adequate Yearly Progress (AYP)

Our school **DID NOT** make AYP
(11 of 13 goals met)

The federal No Child Left Behind Act requires that every school make Adequate Yearly Progress (AYP). State test results are used to set AYP proficiency targets for every grade. Targets are set for the school as a whole, as well as for nine separate subgroups. The subgroups are: white, black, Hispanic, Native American, Asian, multiracial, economically disadvantaged students, students with limited English proficiency and students with disabilities. A school's attendance and graduation rates are also measured for AYP.

The subgroup measurements are intended to prevent an overall score from masking poor results by one or more subgroups. Because the number of subgroups can vary depending on a school's diversity, the number of targets varies also. Some schools may have only a few targets to meet; others may have as many as 41.

AYP is an all-or-nothing standard that says every target must be met. No Child Left Behind also requires that every student be proficient by the 2013-2014 school year.

► ABC Designation

Our school's designation: **Priority School**
(DID meet growth expectations)

Proficiency: 51.0%

The North Carolina ABCs program was introduced more than a decade ago to better target school improvement efforts. Two basic measures determine a school's designation: the Average Growth of students (at right); and the Performance Composite, which measures how well students performed against a set standard of proficiency.

Schools are given one of seven designations (in descending order): Honor School of Excellence; School of Excellence; School of Distinction; School of Progress; No Recognition; Priority School; Low Performing.

► Average Growth

State Standard: 80%
Our School: 81.8%

Each year, the state sets individual growth expectations for each student. A student is expected to perform as well, or better, on the End-of-Grade (EOG) assessment for the current year as he or she did, on average, during the previous two years. The Average Growth is calculated by comparing *actual* performance versus *expected* performance and then averaging the difference across all students and all subjects. The score above reflects the combined growth rate of all of our students. A school classified as making expected growth would have a score of 80% or higher.

► Students Making or Exceeding a Year's Worth of Growth

State Standard: 60%
Our School: 57.5%

This measurement assesses whether students have learned as much as they are expected to learn in one year. Expectations are set for each student based on individual performance for the previous two years. Across the state, about half of students typically meet or exceed their growth expectation. High growth is defined as a score of 60% or higher and having met expected growth.

► Amount of Growth for Students in the Lowest Achieving Group

Our School: 82.1%

Narrowing the achievement gap is widely recognized as one of the biggest challenges in public education. The lowest achieving group for CMS includes certain minority groups and those receiving free or reduced-price lunch. If lower-achieving students grow at a faster rate than better-achieving students, the achievement gap is narrowed. When the above percentage is higher than the Average Growth for the school (see Average Growth above), the school is closing the achievement gap.

► Positive Responses to Student Surveys

Our School: 67.3%

Student feedback is a subjective, but essential, component of the measure of our school's performance. We want all of our students to have a caring, supportive environment at school. This is a measure of the positive reaction from our students covering the areas of school safety, engagement and encouragement.

We did not, however, meet Adequate Yearly Progress (AYP), the standard set for schools by the No Child Left Behind Act. The diversity of our school means we have 13 targets to meet for AYP, and we met 11 of them.

The Lincoln Heights staff is committed to building success for our students, and we have a number of strategies in place to work with each child. We are improving academic progress through differentiated instruction, a flexible teaching approach that adapts the curriculum to individual learning needs. We are also using the Intensive Reading Model, data analysis and strong instructional delivery. Other techniques that improve performance are manipulatives (student interactivity with objects) and structured lesson design.

Our staff is strong, with highly qualified teachers and teacher assistants. Our collaborative model for planning and sharing resources and strategies has helped Lincoln Heights create a sound instructional program. After-school tutoring through Title I and our own tutoring sessions provide customized assistance to meet student

needs. In addition, our staff offers a K-5 reading night, chess club, jazz choir, art club, Right Moves for Youth and math Olympiads to round out our curriculum.

Lincoln Heights is proud of the intangibles that make us special. We have a warm, inviting climate that reassures parents and students that they are valued and that we want to work in partnership. We focus on positives: recognizing students for good work, exemplary behavior, Positive Behavioral Interventions and Supports character traits and strong work ethic. All of these aspects contribute to a productive, meaningful and happy learning environment. Lincoln Heights is a good place to learn and work together.

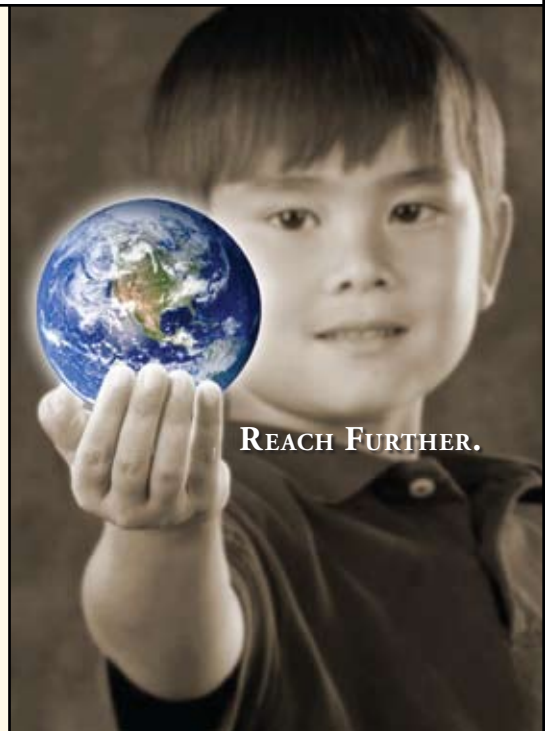
What is the School Progress Report?
