## A Message from the Principal

To our J.H. Gunn Elementary School families:

Our third School Progress Report is intended to keep you fully informed about our students' academic progress, our school environment and our effective educators. You will notice from this report that our staff and students clearly worked extremely hard, resulting in a successful 2009-2010 school year.

We are delighted to share with you the tremendous growth accomplished last school year. J.H. Gunn's composite proficiency rate on the state End-of-Grade tests was 66.7 percent, an increase of 4.4 percent over the previous year.

Our school achieved High Growth status, which means that our students exceeded expectations set by the state. In addition, we made Adequate Yearly Progress, the standard set for schools by the No Child Left Behind Act, by meeting all 29 of our targets.

Through our School Improvement Plan, we continue to address specific areas to increase academic performance. We use a variety of teaching practices to support our students' needs. Most importantly, we use data to determine the students' present academic status and to identify strategies that promote growth. This school year, greater emphasis will be placed on the K-3 intensive reading model. Students in kindergarten through third grade are regularly assessed by classroom teachers. Students who need additional reading support will receive extended reading instruction focusing on phonics, phonemic awareness, fluency, vocabulary and comprehension. Students will stay in this intensive curriculum until they perform consistently at grade level. Those performing at or above grade level will receive instruction at the appropriate academic level. In third through fifth grades, we focus on teaching to students' individual levels, flexible groups, research-based assessments and quality teaching practices to increase student achievement.

To help students in reading, math, writing and science, we offer extended-day tutoring from October through May. We are fortunate to have

additional tutoring support throughout the school year from a group of outstanding Providence Day School students. In addition, many of our parents and community supporters volunteer to tutor students. Our talent development program provides an enriching curriculum for students at or above grade level. After-school programs include Science Olympiad, chess club and Scouts.

At J.H. Gunn, we stress the importance of attendance through our Watch An Eagle Soar program where staff members mentor students, stressing the importance of attending school each day. I am proud to report that our students made their attendance goal for the 2009-2010 school year.

A safe learning environment has been one of the key factors to our success at J.H. Gunn. We received 97.6 on our first safe school audit and our school survey indicated that 100 percent of our students feel safe at school. During the second audit, our custodians were using heavy machinery to clean the cafeteria floors and did not hear the lockdown code. We have introduced proactive measures for success in the future.

All staff members are invested in the students and are dedicated to providing the best educational experience possible. Our faculty is strong and all of our teachers are highly qualified. Teachers volunteer to provide after-school tutoring, and our support staff provides individualized instruction in small group settings. We are ably supported by our PTA and school leadership team, and their collaboration is essential to the success of our students.

We are committed to raising student achievement at J.H. Gunn. I am confident that the combination of an enriching academic program, effective teachers, parental support and a safe and orderly environment will help us to continue to excel at J.H. Gunn Elementary.

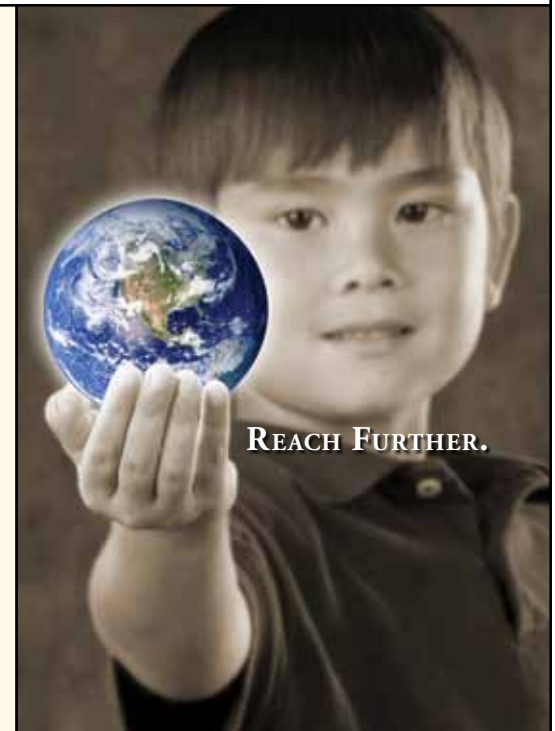

## CMS Accountability Measures

The learning of students in public education is measured in multiple ways. There are assessments given at regular intervals by CMS—tests that we use to measure how students are learning as the school year progresses. Other tests are required by the state and given once or twice a year, such as End-of-Course and End-of-Grade tests. Some of the state test results are also used to calculate district progress on the federal standard of Adequate Yearly Progress for each student. This page provides brief explanations of some of the measures and tests used in CMS.

### ▶ Adequate Yearly Progress (AYP)

Our school **DID** make AYP  
(29 of 29 goals met)

The federal No Child Left Behind Act requires that every school make Adequate Yearly Progress (AYP). AYP is an all-or-nothing standard: Every target must be met.

State test results are used to set AYP targets. There are separate targets for the school as a whole and for nine subgroups of students: white, black, Hispanic, Native American, Asian, multiracial, economically disadvantaged students, students with limited English proficiency and students with disabilities. Subgroups of students are measured separately so that an overall score for a class or a school does not mask poor results within a subgroup.

Some schools are more diverse than others, so the number of subgroups varies by school. Therefore, the number of AYP targets varies by school, too. Some schools may have only a few targets to meet; others may have the maximum, which is 41. School attendance and graduation rates are also measured for AYP.

### ▶ ABC Designation

The North Carolina ABCs program was introduced more than a decade ago to help schools improve. It uses two basic measures to assess a school's performance: the Average Growth of students (at right); and the Performance Composite, which measures how well students performed against a state-set standard of academic achievement.

Schools are given one of seven designations. In descending order, they are: Honor School of Excellence, School of Excellence, School of Distinction, School of Progress, No Recognition, Priority School, and Low Performing.

### ▶ Average Growth

Did our students meet the state's expectation for academic growth? Each student is expected to perform as well (or better) on the End-of-Grade assessment as he or she did, on average, during the previous two years. Average Growth for a school is calculated by comparing actual performance to expected performance and then averaging the difference across all students and all subjects. The score above reflects the combined growth rate of all of our students. To make expected growth, a school must have a score of 80 or higher.

### ▶ Amount of Growth for Students in the Lowest-Achieving Group

Our School 2008-09: 83.5      **Our School 2009-10: 80.2**

Are we helping our low achievers catch up? Historically, some economically disadvantaged and minority students have trailed their classmates in academic achievement. This is called the achievement gap, and closing it is one of the biggest challenges in public education. If the lower-achieving students at a school show academic growth at a faster rate than higher-achieving students, the achievement gap is narrowed. When the score for this measure is higher than the Average Growth for the school, the school is closing the achievement gap.

### ▶ Students Making or Exceeding a Year's Worth of Growth

Did our students learn as much as they were expected to learn this year? As described above, the state sets expectations for each student based on individual performance for the previous two years. Across the state, about half of students typically meet or exceed this growth expectation. To earn the high-growth designation, a school must meet the average-growth standard described above and also have more than 60% of its students make expected growth.
